## Opening Ceremony of the academic year

Javier Solana, High Representative for the Common Foreign and Security Policy and Secretary-General of the Council of the European Union, as well as President of the Madariaga European Foundation, opened the 56th academic year at the Bruges campus of the College of Europe on Wednesday, 19 October. Prior to Mr Solana's speech, the Rector of the College of Europe, Paul Demaret, reported on the state of the College in 2005/06 and then introduced the patron of this year's promotion and author of the European anthem, Ludwig van Beethoven. In addition, the Rector highlighted the creation of a new study programme in 2006/07 in EU International Relations and Diplomacy.

In his speech, Mr Solana questioned why so much scepticism currently exists concerning the European Union and, arguing that Europe has never been so successful, pointed to its peace, prosperity and freedom. According to him, the European journey must continue, but trust and popular support need to be regained. In foreign policy, the EU is already operating nine peace support operations and is recognised as an important actor. If looking at EU foreign policy from a long-term perspective, it is getting better, and therefore the EU 'must be more ambitious and step up [its] engagement.' Mr Solana also emphasised the need for Europe to have the resources necessary, whether human or financial, in order to perform the tasks that are needed. The Constitution was a way to provide these, and even with the current impasse, the reasons for drafting the Constitution remain – to create a more streamlined and effective Union.

Finally, Mr Solana called upon students to 'chart a new course for Europe in a more demanding global context' in their future careers; 'to build a Europe focused on new tasks, but based on the same values'.

Following the speech, Jean-Luc Dehaene, President of the Administrative Council of the College of Europe, officially opened the academic year.

## International Workshop on Terrorism

From 24-25 November a workshop on "International Terrorism – A European Answer to a Global Threat" was held at the College's campus in Bruges. The conference was organised by the Department of European Political and Administrative Studies.

The purpose of this workshop was to assess the current threat of terrorism from a European perspective and to analyse the European response to it. Over two sessions the definition of terrorism and existing counter-strategies at the EU level were discussed. In the first session on "The EU and the challenge of international terrorism" participants dealt with the definition, consequences and the new character of terrorist activities in recent years. In this context the international dimension of the topic was emphasised and it was asked whether there is a specifically European view on this modern challenge? During the second session, "The EU Response: External Action and Internal Measures", current responses and the level of cooperation among member states were presented and discussion centred on whether the EU's approach is currently adequate. The question of balancing domestic security concerns against basic freedoms was one of the most intensively discussed issues during the second half of the conference.

The consensus opinion was that Europe is becoming an increasingly coherent and pro-active player in the global arena of anti-terrorist measures. It was noted that the European Union is making an effort to provide a comprehensive answer to the challenges faced. Given the interconnection of the roots of terrorism and the measures to be taken, the EU's most effective strategy to follow remains a contentious subject for further discussion.

The workshop was opened by the Rector of the College, Prof. Paul Demaret. The two sessions were chaired by Prof. Dieter Mahncke, Director of the Department of European Political and Administrative Studies, and Prof. Jörg Monar, Marie Curie Professor at the University of Strasbourg.



Participants included high-level academics and professional experts from Europe, the United States and Asia, and the workshop was also open to College staff and students. In this way, the College demonstrated its commitment to making a contribution to the debate on terrorism and to providing a forum for the interdisciplinary exchange of views between academics and practitioners. Given their valuable and original character, it was decided to make the debates available to a wider audience, and so the contributions will be published next year in the College of Europe Studies series in a work to be co-edited by Prof. Mahncke and Prof. Monar.

### Training on international trade issues

In 2005 the College received further recognition of its training expertise in the field of international trade issues. For the fourth year in a row, the Development Office of the College organised a series of seminars in Brussels for newly appointed officials of the European Commission (DG Trade). In the framework of a service contract with the Commission, renowned professors and training experts of the College tailored modules of between two and four days to the specific expectations of the DG Trade officials participating in each of the seminars.

Over the past four years more than 160 officials have participated in different modules, focussing on the most crucial legal aspects and on the economics of international trade. A module on International Trade negotiations was designed to reinforce practical skills through a number of simulations. New seminars are planned for 2006 within the framework of the same service contract.

A further step has been taken in reinforcing the trade component of the College's training activities with the launching of a trade capacity-building project for the authorities of Mauritius in 2005. In the framework of this project, six international trade experts have been deployed by the College Development Office to support Mauritius in strengthening its capacity to participate effectively in WTO negotiations and to implement WTO Agreements.

Under a third project the College will coordinate a series of conferences to promote an informed debate on the EU's Trade Policy among civil society actors in the new Member States of the EU. The Development Office of the College is cooperating with the European Movement and Eurochambers in organising workshops at three different locations in 2006.

### Conference on Turkish Accession

The successive ratification failures of the European Constitutional Treaty in France and in the Netherlands may or may not have endangered Europe's integration process, but they have undoubtedly led to questions regarding the current state of the European project. The argument progressively focused on acceptance of the former enlargement, and, consequently, of further ones. Nevertheless, the prospect of Turkish membership, a concern for many and formally rejected by some, did not appear to be fundamentally questioned.

Shortly before the opening of accession negotiations, Sylvie Goulard (Sciences-Po Paris and College of Europe, Bruges) and Binnaz Toprak (Boğaziçi University, Istanbul) discussed this issue on the Natolin campus of the College at the invitation of Professor Geremek using a different approach from the usual discourse. Since the fundamental question of whether Turkey is European or not by and large still remains open, instead of the Europeanness or the enlargement policy, the changing patterns of societies and political behaviours were considered. In addition, the mental and social aspects of this prospective enlargement, especially as these relate to Western European social and cultural standards, were discussed. So, are the European Union and Turkey ready to accept one another?

In a very passionate and sometimes heated debate, both speakers agreed that in certain aspects the two parties were not yet ready. But, their views differed regarding the possible transformation of Turkish society because of the prospective accession, and the fear that, although defensible, this enlargement would endanger the hitherto assumed nature of the European integration project: an integrated political entity. Calling upon many arguments used in the lost referendum campaign, Prof. Goulard argued that one clear demand emerges from what can be considered a defeat: the forthcoming enlargements should be appraised and led in a completely different manner from the previous ones. It remains to be seen whether this will be the case, and it is likely that these discussions on Turkey's accession will continue during the coming years.

## Workshop on Intellectual Property

A workshop on 'Issues of Public Policy and Trade in Intellectual Property Law' took place at the Bruges campus on 5 October 2005 at the initiative of Rector Paul Demaret, Professor Inge Govaere, Director of Legal Studies at the College of Europe, Bruges and Professor at Ghent University, and Professor Hanns Ullrich, Professor at the European University Institute in Florence and Visiting Professor at the College of Europe, Bruges, and with the financial support of the Microsoft Corporation.

The morning session, chaired by Professors Ullrich, Jerome Reichman (Duke University) and Thomas Dreier (Karlsruhe University), stimulated an interesting debate dealing with the potential conflict between public interest concerns and a system of protection of Intellectual Property. This was followed by a contribution by Professor Gustavo Ghidini (LUISS University in Rome) and Professor Geertrui Van Overwalle (Katholieke Universiteit Leuven) to the current debate on biodiversity.

The afternoon session, chaired by Professor Govaere, was devoted to two rather different topics. First, Professor Klaus Stegemann (Queen's University, Canada) and Dr. Carsten Fink (World Bank) examined the question of price discrimination for pharmaceuticals from a social welfare perspective. Professor Thomas Cottier (Bern University) and Dr. Christine Godt (Bremen University) then discussed the consequences of the recent Doha waiver compromise reached in the framework of the WTO.

These various issues were raised again in a final panel discussion chaired by Professor Frank Gotzen (Katholieke Universiteit Brussel). The panel discussion benefited from the reflections of Professor Dominik Hanf (Professor at the College of Europe, Bruges), Dr. Brendan Barnes (EFPIA) and Professor Alain Strowel (Facultés Universitaires Saint-Louis).

A number of College students, as well as the assistants of the Legal Studies Department, attended the Workshop. The high level of the participants allowed in-depth discussions on the different issues, making the Workshop a success. The outcomes will soon be made available in a book, which will be published in the "College of Europe Studies" series.

## Mémoire européenne ou mémoire des Européens ?

A l'initiative du Professeur Geremek et du Vice-Recteur Robert Picht, la conférence 'Construire une mémoire commune ?' a réuni à Natolin le 14 octobre Tzvetan Todorov (Paris), Anne-Marie Thiesse (Paris), Ute Frevert (Yale) et Bo Stråth (Florence), chacun accompagné d'un « junior academic » afin de donner une dimension intergénérationnelle supplémentaire aux débats.

Le problème posé par la question de la mémoire commune des Européens ne semble jamais relever de l'impératif, du spectaculaire ou de l'urgence – pour autant, chacun s'accorde à reconnaître qu'il présente un défi réel, sous-jacent mais croissant, d'une actualité politique et philosophique persistante. Fondamentale à toute communauté car elle fonde le sentiment d'appartenance à celle-ci, la question de la mémoire commune se retrouve obstinément au cœur des débats sur l'identité des Européens et l'avenir de l'Europe, et inversement. De plus en plus, l'essoufflement spectaculaire des moteurs traditionnels de l'intégration européenne conduit une classe politique souffrant d'un certain manque d'imagination à solliciter le passé pour dégager les visions de l'avenir et pallier l'absence de projet.

Les Lumières nous enseignent que s'il existe une identité commune en Europe, c'est bien dans la capacité à prendre de la distance par rapport à sa propre mémoire : « être européen, c'est savoir prendre ses distances d'avec soi-même » (Todorov).

One year after the Orange Revolution shook public opinion from all over the world, the College of Europe organised the conference "Ukraine on the move" on November 28 to review and analyse the current state of affairs in the country and its pending challenges. The discussion was held around four thematic panels: the European Neighbourhood Policy, Foreign Affairs, Rule of Law, and Economic reforms.

Speakers included top-level Ukrainian politicians, key representatives from the European institutions, NATO and the UK Defence Academy, academics and experts currently working on Ukraine.



## Le Collège d'Europe lance le programme d'études en relations internationales et diplomatiques de l'Union européenne

Le programme d'études en relations internationales et diplomatiques de l'Union européenne a été lancé en présence de M. Javier Solana, Haut représentant pour la PESC et Secrétaire général pour le Conseil de l'Union européenne, lors de la cérémonie d'ouverture annuelle du Collège d'Europe. Ainsi, le Collège répond à l'intérêt croissant d'étudiants et de praticiens pour les relations extérieures de l'Union européenne. Non seulement les pays membres, mais aussi les pays tiers et les organisations internationales voient de plus en plus dans l'Union européenne un acteur mondial important.

Le nouveau programme intéressera particulièrement des jeunes fonctionnaires et des jeunes professionnels ainsi que des étudiants des pays non européens. Les candidats disposeront d'un diplôme en sciences politiques, études européennes, juridiques, économiques ou histoire et pourraient également être détachés d'organisations internationales et de ministères nationaux. Ils doivent démontrer une connaissance approfondie de l'anglais et une connaissance élémentaire du français.

En procurant une connaissance approfondie de l'Union européenne en tant qu'acteur international et une formation à la négociation internationale et diplomatique, ce programme intensif d'une année, débouchant sur un Diplôme d'Etudes Approfondies en Relations Internationales et Diplomatiques de l'Union européenne, préparera les étudiants à différents types de carrière dans le domaine des affaires européennes et internationales.

Le programme se déroulera sur le campus de Bruges en Belgique et comprendra un séjour de cinq semaines sur le campus de Natolin (Varsovie, Pologne). Le département sera dirigé par le Professeur Dieter Mahncke. Au premier semestre, des cours interdisciplinaires portant sur les relations internationales et les matières européennes serviront de base pour une spécialisation. Au second semestre, les étudiants suivront des cours portant sur les thèmes de l'Union européenne suivants : la sécurité et la justice, les relations économiques étrangères, la diplomatie bilatérale et multilatérale, et les compétences professionnelles. Les étudiants suivront un cours de français, ou en cas de bonne connaissance du français, d'allemand, d'espagnol ou de russe. Le programme sera complété par un mémoire. Initialement, il sera limité à une quarantaine d'étudiants.

## Borders, buses and a revolution – the Natolin study trip

In late October the students of the Beethoven Promotion of the Natolin campus left for the traditional first semester study trip. The theme of this year's trip was "Borders and Borderlands" with a specific focus on the new external boundaries of the enlarged European Union. Therefore, the destination of the trip, the border region of Poland and Ukraine, was an ideal case study. This is particularly true for the region of Transcarpathia in south-western Ukraine with borders, quite volatile throughout history, extending to four different countries (Hungary, Poland, Romania and Slovakia). The region has at some point or another been claimed by all neighbouring countries as their territory and its ethnic and cultural composition is extremely diverse.

The week prior to our departure, a number of preparatory seminars and lectures, among others a meeting with Mr. Laitinen, Executive Director of the recently established FRONTEX Agency, were organised to offer initial impressions of what was lying ahead. For most, this was to be the first trip to Ukraine and most information about the country stemmed from the late 2004 Orange Revolution in Kiev (not least through an excellent presentation by our fellow revolutionary Natolinian student Ania Yatsyuk).

The first days of the trip comprised a fact-finding mission at the Polish-Ukrainian border check point and the "Wider Europe" seminar in Lviv. We also visited the cities of Chernivtsi (Bukovina) and Uzhhorod where we discussed problems of multiethnic society and cross border cooperation. Some students prepared presentations and guided tours in the castles and cities of Kamyanets Podilsky and Khotyn, which brought the topics much closer to us. One of the unforgettable moments was the performance of the "Ruthenian National Anthem" by a group of students (featuring Vice-Rector Robert Picht) during a picnic at the bank of the river Prut, a natural border with Romania. Even what sometimes seemed to be an endless bus ride certainly contributed to the famous "Natolinian spirit".

Overall, the 2005/06 study trip to Ukraine was both an exciting and challenging experience and gave us a whole new perspective on the notion of borders. It was not only interesting to see such a large and important neighbouring country to the EU but also to look at our current home country, Poland, from the Eastern side of the border.

### Construction at Verversdijk continues

The first phase of the Verversdijk expansion project of the Bruges campus of the College of Europe is expected to be completed by 2007. In 2005 restoration work on the existing building, formerly part of a Jesuit training school, was completed: this will house a number of academic staff. In addition, work on the two additional buildings continued during 2005. The first of these, on which construction work began at the end of 2004 and whose façade is now almost complete, will house two auditoria, a foyer, and the ICT Service. Twelve flexible seminar rooms, a reception area and an underground bicycle shed will be housed in the second building. By providing additional space for the College, the Verversdijk buildings will allow the College to expand its academic activities.

### The Intensive Seminar on the EU – more than 700 participants over the years

In July 2005, the College organised the twelfth edition of its Intensive Seminar on the EU in Bruges. Over a three-week period this training programme brought together seventy professionals from over twenty countries, participating in one or more of its modules.

The programme of the Seminar is evolving on a yearly basis, following the latest developments in different spheres of EU policy-making. It continues to stick, however, with its tradition of allowing participants to shape their own training curriculum by choosing among different parallel sessions. Over recent years a stronger emphasis has been placed on individual practical and professional skills, and on enabling the participants to literally 'experience' the EU through workshops and simulation games recreating the EU's working procedures. The different training formulas are based on intensive and diversified teaching, workshops, and social programmes, which taken together enable participants not only to get a thorough understanding of the EU's institutions and processes, but also to experience the 'esprit' of the College of Europe by living and working together in the College and its student residences, in an intense multicultural environment.

More than 700 professionals have participated in the Intensive Seminar over the past 12 years. Some countries, like Canada, have introduced the programme into their preparation scheme for diplomats posted to their Mission to the EU. The participants are primarily civil servants and diplomats, but over the years academics and private sector professionals have become increasingly represented.

The 2005 edition introduced a one-week training formula into the programme, addressing a limited audience of 25 time-constrained professionals with a solid proven knowledge of the EU. This 'compact formula' focused exclusively on the most recent developments in the core areas of European integration, providing the participants with ready-to-use information, opportunities for discussion and an exchange of ideas with renowned experts.

### Prix de l'Ancien

Fabien Durand, President of the Alumni Association of the College of Europe, introduced the three finalists for the Alumni of the Year Award on 9 December 2005 in Oslo. The recipient of this year's award is Mrs **Nuala Mole** (Comenius promotion, 1967/1968).

Nuala was selected from 22 alumni nominees to receive this year's award due to her dedication to making practical information and advice about the rights conferred under EU law available to the public. In 1993 Nuala set up the AIRE Centre to serve this purpose, while also providing advice concerning the rights conferred by the European Convention on Human Rights. The Centre quickly developed a niche service advising on all aspects of human rights and EU free movement rights. In addition to high profile cases, the AIRE Centre has assisted thousands of individuals.

As her nominators wrote, "these achievements are without doubt due to Nuala's dedication and energy. The AIRE Centre remains a small organisation driven by the dedication of a small staff and hundreds of interns from all over the world, to whom Nuala has always generously given her time in training and support. As former interns ourselves we truly value this opportunity to make rights become reality. Moreover, Nuala's friendship and passion for the European ideal has inspired all who work with her. Under her leadership, employees and volunteers continue to help strengthen rights across Europe, long after their time working at the AIRE Centre."

"I think the main challenge across Europe for the next decade is to be absolutely sure that we do not allow the concerns that everyone rightly has about our safety and security to undermine the principles of justice and fairness that it takes us many centuries to acquire. We must work very hard to defend our security but we must also work very hard to defend our human rights."

## Lancement de la publication 2005 du Programme Anna Lindh à New York et à Stockholm

Coller au plus près à une actualité permettant à l'Union européenne de jouer un rôle moteur sur la scène internationale dans le domaine de la prévention des conflits constitue une caractéristique essentielle du programme Anna Lindh, initié par la Fondation Européenne Madariaga fin 2003 à l'initiative de son Président, Javier Solana.

"Development, Security and Conflict Prevention: Security as a Millenium Goal", thème retenu en 2005 pour la seconde publication du programme, s'inscrit ainsi dans la lignée de la préparation du Sommet des Nations-Unies sur les objectifs du Millénaire pour le Développement (OMD).

C'est donc logiquement en marge de ce sommet que fut lancé le 14 septembre dernier, à New York, la deuxième publication du programme Anna Lindh. Le bureau de liaison de l'Union européenne auprès des Nations Unies a accueilli cet événement qui a rassemblé un grand nombre de personnalités malgré un agenda officiel chargé en cette période de l'année.

La présentation de l'ouvrage a été l'occasion d'un débat passionnant entre Jim Cloos, Directeur au Secrétariat Général du Conseil de l'Union européenne et Evelyne Herfkens, Coordinatrice du Secrétaire Général pour la campagne de promotion des OMDs.

La discussion ouverte et animée qui a suivi a mis l'accent sur la complémentarité mais aussi la nécessité d'une coopération renforcée entre les Nations Unies et l'Union européenne dans leurs activités de promotion du développement et de la prévention des conflits.

Si le lancement New Yorkais s'imposait cette année au regard de l'actualité internationale, la Fondation Européenne Madariaga tenait néanmoins à maintenir un lien étroit avec le public suédois en hommage à Anna Lindh, inspiratrice du programme.



L'inauguration à Stockholm le 10 novembre dernier par Margot Wallström de la nouvelle Bibliothèque Anna Lindh, entièrement consacrée aux affaires internationales, a offert un cadre idéal au lancement de l'ouvrage sur la scène suédoise.

La Vice-Présidente de la Commission européenne, proche d'Anna Lindh et membre du comité de

patronage du programme mis en œuvre par la Fondation Européenne Madariaga, a assuré une présentation à la fois chaleureuse et engagée de l'ouvrage (voir encadre ci-dessous), rappelant en des termes touchants le combat de sa compatriote pour faire de la prévention des conflits un des fers de lance de la politique étrangère européenne.

La politique de développement représente sans nul doute un des piliers d'une politique structurelle de prévention des conflits. L'impact de cet instrument est réel et les résultats positifs doivent être mis en avant par une Union européenne toujours modeste dans la communication de ses succès.

## Genocide Prevention: theory to practice

"The progression of events toward genocide is gradual, and the years from initial threat to full genocide offer an interval for the international community to take preventive action." This assertion by David Hamburg, President Emeritus of the Carnegie Corporation of New York, constitutes the premise of a forthcoming study proposing to explore the feasibility of setting up an International Centre for the Prevention of Genocide. The study, initiated in the aftermath of Raymond Georis' meeting with President Jimmy Carter in Atlanta in September 2005, opens a new collaboration between the Carter Center and the Madariaga European Foundation. The Folke Bernadotte Academy of Sweden, as well as a personal representative of Javier Solana, will also participate in this endeavour. The feasibility study will consist of a series of Steering Committee meetings to be held between January and June 2006, under the chairmanship of David Hamburg, and coordinated by the Madariaga European Foundation.

## Health as a key issue



The Centre for Health, Ethics and Society (CHES), created in 2003, is one of the key health programmes of the Madariaga European Foundation. With the support of Johnson & Johnson, it aims to improve European integration through dialogue and debate on healthcare, ethical and societal issues.

Activities consist of facilitating discussion and dialogue, bringing together representatives of the EU institutions, academic, advocacy, corporate, government, medical and scientific organisations in order to influence the public policy arena. To this effect, CHES organises roundtables where all stakeholders meet to discuss topical EU health issues.

The most recent one, on November 23rd 2005, focused on the recently published Green Paper of the European Commission on Mental Health. It provided an opportunity for stakeholders from the mental health field to enter into dialogue with representatives of the European Commission and the European Parliament. The next event, planned for February 2006, will address the proposed health activities of the future EU Framework Research and Development Programme.

## Roundtable on Eurocarers

The CHES Roundtable, organised in partnership with Eurocarers, on 20 September 2005 at the Madariaga European Foundation, aimed to explore the practical possibility of placing issues related to informal care firmly on the EU policy agenda.

Based on the figures of the demographic dependency ratio (expected to rise from 49% in 2005 to 66% in 2030), and given the fact that most of the care is provided on a voluntary basis by relatives (i.e. friends and neighbours), this informal care is a critical element in addressing the sustainability and quality of health care systems – a challenge faced by all EU member States.

In many cases, the important work carried out by carers is unrecognised and unpaid, and policies need to ensure that this important care resource is being maintained.

The roundtable brought together a number of key representatives of the European Commission's Employment and Research DGs as well as of the European Parliament, health advocacy groups, academics and health professional organisations.

Mrs. Brigid Barron, President of Eurocarers, described the needs of carers and the challenges they face, stating "the need to care about carers and take into consideration their long hours of work, stress, isolation and loss of freedom of choice".

Mrs. Kathy Sinnott, Member of the European Parliament, stressed that "caring is a necessity for the human person as well as for society; carers are workers and thus they have to be remunerated for their work. EU policies should address carers as workers".

## Highlights of the debate on Avian Flu

On 29 November 2005, the Madariaga European Foundation held a timely lunch debate on: "Avian flu crisis: a European response?" Both guest speakers, Dr. Luc Hessel of the European Vaccine Manufacturers and Mr. Alexander Woollcombe, assistant to MEP Robert Sturdy, stressed the need of a coordination between EU member states on a health-related issue, albeit still of national competence is. The debate was moderated by Vanessa Witkowski from Café Babel.



The speakers described the specificities of a pandemic in which the entire population (pan = all, demos = population) is at risk and not only specific segments. A pandemic can occur anytime, whereas annual epidemics are mostly seasonal, and is very severe, as far as potential mortality rates are concerned.

In the second part of the debate, the question raised was not *if* but *when* a pandemic could occur and the need for the member states, the European institutions and the private sector to be well prepared. Having a preparedness plan ready is essential, and the different actors need to know what they are expected to do and at which stage they are involved.

Finally, both speakers insisted on the need to differentiate the media reaction to avian flu, which is rather cyclical, and the work of the European institutions and the laboratories, which has a long term perspective. In conclusion, this pandemic threat could be seen as a learning experience of coordination and communication that will help to make progress in other areas.
