LANGUAGE OF INSTRUCTION

German (& English explanations)

1. COURSE OBJECTIVES

The aim of this German language course for beginners is to reach the equivalent of an A1+ level according to the Council of Europe's Common European Framework of Reference for Languages (CEFR). The course aims to develop the four fundamental skills of listening, reading, communicating and writing by using appropriate teaching material completed by self-learning online exercises.

At the end of this course, the student will be able to

- understand sentences and frequently used expressions related to areas of most immediate personal relevance
- read short texts and find specific information in everyday material
- communicate in simple and routine tasks
- ask and answer simple questions in areas of immediate need or on very familiar topics
- describe in simple terms aspects of his/her background and immediate environment
- produce short notes and texts

2. LEARNING OUTCOMES

The course objectives tie in with the following learning outcomes of the programme **EU International Relations and Diplomacy Studies**:

3. COURSE CONTENTS

- First semester: focus on morphology, syntax and on oral skills.
- Second semester: focus on morphology, syntax and written and oral skills.

4. TEACHING METHOD

Students are expected to regularly attend the class, to participate actively in the exercises in class and to prepare the required homework.

The communicative aspect will be paramount. From the beginning, the course will be based on the linguistic tools that are necessary to be able to carry out authentic communication in German. Students and teacher will either together or individually or in small groups do specific listening, reading, intonation, grammar and writing exercises. For example, the student should have the competence to ask for and to give information to somebody else, to make appointments, to express positive and negative reactions and opinions, to talk about personal and professional situations, to write e-mails and to fill in forms.

The unjustified absence from coursework which counts towards the mark of the course, will result in a mark of 0 for that part of the assessment (the student will only be excused in case of illness based on a medical certificate to be provided to the Academic Administration Office). The student must inform the professor in advance of any absence.

5. COURSE MATERIAL

“*Das Leben A1*” consisting of one combined teaching and working book. The book is available for purchase at the College bookshop.

This material will be completed by Internet exercises tailored to the book chapters.

6. EVALUATION

This course is assessed on a ‘pass/fail’ basis:

- pass: no mark will be attributed, and the CEFR level of graduation will be mentioned on the transcript.
- fail: a mark is attributed and mentioned on the transcript and will be taken into consideration in the calculation of a possible compensation.

The mark is composed of the following elements:

- continuous assessment throughout the course (50%)
- final examination at the end of the course (50%): written exam of 2h

In case of a second-session resit (2h), the written exam counts for 100% of the final mark.
