## 1. COURSE OBJECTIVES

- 1) Understanding the nature and scope of social inequalities in Europe (in relation to race, class and gender, among others) as well as the theoretical frameworks and social actions that contribute to overcome them.
- 2) Provide students with first-hand experience of policy making in the EU, from the evidence-based identification of issues to the conception, negotiation and implementation of answers.
- 3) Provide students with first-hand experience about the methodologies for monitoring and evaluation of social and policy impact of research in the EU.
- 4) Gender equality has carried strong and innovative policy answers to address some aspects of inequalities. Both their effectiveness and limitations will be analysed during the seminar.

## 2. LEARNING OUTCOMES

On completion of the course, the student will be expected to be able to understand social and gender inequalities as a political issue and to think in a critical way about the potential role of the EU in addressing the problems linked to stalling or rising social and gender inequalities.

## 3. TEACHING METHOD

The course will be taught by lectures by the professors and guest speakers, case studies, class discussions and student presentations

## 4. ASSIGNMENTS

Students will be requested to participate actively in class discussions, to prepare for a small group or individual presentation, and to write an independent paper on a relevant subject of their choice related to the course.

- SESSION 1: Social inequalities and intersectionality in Europe: race, class, gender, ethnicity, cultural capital, religion
- SESSION 2: Successful actions in the overcoming of social inequalities
- SESSION 3: Inequalities, gender and gender equality
- SESSION 4: History of the EU gender equality policy
- SESSION 5: Social policies with social impact in Europe
- SESSION 6: Dialogic policy and implications for Europe. Presentations by students
- SESSION 7: Make it happen, Institutions, instruments and tools
- SESSION 8: Students' presentations and special session on Feminist diplomacy: case study on Sweden and France
