#### **KEYNOTE SPEECHES:**

## H.E. Mr. WU Hailong

H.E. Mr. WU Hailong graduated from the Beijing Foreign Studies University. He joined the Foreign Service of the People's Republic of China (PRC) in 1978. He has served in the Department of International Organisations and Conferences since 1978 and in 2006 became Director General of the Department. Before assuming his position as Ambassador of the PRC to the EU in 2012, H.E. Mr. WU was Assistant Minister of Foreign Affairs, responsible for International Organizations and Conferences, as well as for Arms Control. Previously he served as Permanent Representative, Ambassador Extraordinary and Plenipotentiary of the Permanent Mission of the PRC to the United Nations and other international organisations.

#### Mr. Gerhard STAHL

Mr. Gerhard STAHL graduated from the Technical University of Berlin. Mr. Stahl served in the Ministry of Economics, Transport and Research on the regional level at Schleswig-Holstein, and as General Director for European and International Affairs at the Ministry of European and Federal Affairs. From 1995 until 1999, he was a Member of the Cabinet of Dr Monika Wulf-Mathies, European Commissioner for Regional Policy and from 1999 until 2002 – Deputy Head of Cabinet for Pedro Solbes, European Commissioner for Economic and Monetary Affairs. In September 2002, Mr Stahl was appointed Director for Consultative Work at the Committee of the Regions. He has been Secretary-General of the Committee of the Regions since 1 April 2004.

#### PANEL ONE: DIALOGUE AND SOFT DIPLOMACY BETWEEN THE EU AND CHINA

## **Chair:**

## **Prof. Pierre DEFRAIGNE**

Prof. Pierre DEFRAIGNE is currently Executive Director of the Madariaga-College of Europe Foundation. He retired as Deputy Director-General in DG Trade in March 2005 after having been Head of Cabinet for Pascal Lamy, European Commissioner for Trade (1999-2002). He set up the Brussels branch of the Eur-Ifri, which he managed from 2005 to 2008. He is a lecturer in political economy at the College of Europe, and economic policy in the EU at the Paris School of International Studies. He also taught at the Institute for European Studies, Université catholique de Louvain (UCL) and Facultés universitaires Saint Louis (FUSL) and at the Zhejiang University. His interests focus on international economic policies, political economy and relations with developing countries.

#### **Dr. Joelle HIVONNET**

Dr. Joëlle HIVONNET holds an MA in International Politics from UCL. She is the author of a Ph. D thesis on "The Effects of the ratification by the United Kingdom of the European Convention on Human Rights", that she received from Paris X University. Dr. Hivonnet has been a European Official since 1992. In the course of her EU career, she has contributed inter alia to the adoption of the European anti-discrimination directives, to the implementation of the EU education and culture policies and to the representation of the EU at the UN and other multilateral fora in New York and Geneva. Dr. Hivonnet is currently working in the China Division in the European External Action Service (EEAS) where she is contributing to the implementation of the EU-China strategic partnership.

## Dr. Kolja RAUBE

Dr. Kolja RAUBE studied Political Science, European and International Law at the University of Marburg, University of Saskatchewan and the University of Hamburg. He has a DPhil in Political Science from the University of Hamburg. Dr. Raube is currently Senior Member of the Leuven Centre for Global Governance Studies, Catholic University of Leuven. He is Programme Coordinator and lecturer in the inter-disciplinary "Master Programme of Arts in European Studies: Transnational and Global Perspectives on Europe" at the Catholic University of Leuven. He also teaches "European Foreign Policy" at the Armenian Diplomatic Academy in Yerewan in a project which is financed by the European Commission and implemented by the College of Europe in Bruges.

#### Mr. Matthieu BURNAY

Mr Matthieu BURNAY holds a BA in Political Science and a BA in Law from the Facultés universitaires Saint Louis in Brussels. He obtained a double MSc degree in International Affairs from Peking University and the London School of Economics and Political Science. Mr. Burnay currently serves as Project Manager of the InBev-Baillet Latour EU-China Chair at the Catholic University of Leuven and is a Junior Researcher at the Leuven Centre for Global Governance Studies, Catholic University of Leuven. He is also the teaching assistant for the course "Chinese Law from a European Perspective." His main research interests include EU-China relations in global governance, China and the rule of law and Chinese foreign policy.



#### Dr. Ida MUSIALKOWSKA

Dr. Ida MUSIALKOWSKA obtained an MSc in European Studies at the University of Economics in Poznan. She obtained a PhD in Economics and International Relations from the Poznan University of Economics. Since 2008 Dr. Musialkowska has been the Director of the Postgraduate Studies Programme "Strategy of EU Funds Acquisition and Management" at the Poznan University of Economics. She provides expertise and analysis on European Integration issues to the Committee for European Integration at the Polish Ministry of Foreign Affairs, to the Parliament of Poland and the Polish Senate. Previously, Dr. Musialkowska was a member of the Expert Group on the EU Structural Funds at the Office of the Ombudsman.

### Dr. Marcin DABROWSKI

Dr. Marcin DABROWSKI graduated from SciencesPo Paris with an MRes in Compared Societies and Policies and an MA in Political Science. He obtained a PhD from the Centre for Contemporary European Studies at the University of the West of Scotland. Dr. Dabrowski is currently an Assistant Professor at the Institute for European Integration Research at the University of Vienna. The courses that he teaches include: "Multi-level Governance in Public Policies", "Contemporary Developments in Central and Eastern Europe", and "Central and Eastern Europe: Politics, Economies, Societies". Furthermore, he used to teach courses at the University of the West of Scotland, the University of Glasgow, the University of Aberdeen, Sciences-Po Dijon and Catholic University of Leuven.

#### Mr. Xavier NUTTIN

Mr. Xavier NUTTIN has served at the European Parliament since June 2005. He is currently Senior Analyst in the Directorate General for External Affairs of the European Parliament where he covers Asia. He provides tailor-made political analysis of Asian countries and gives advice to parliamentary bodies such as the Foreign Affairs Committee. Prior to his current position, Mr. Nuttin was an official of the European Commission. In the 1990s he was posted to the European Commission Delegations to Thailand and Vietnam. In the 1980s he worked for UNESCO, UNICEF and the World Bank in several Asian countries.

## Ms. Verena NOWOTNY

Ms. Verena NOWOTNY holds a Master's degree in Political Management from the George Washington University. Ms. Nowotny is currently an independent strategy and communications consultant with regular policy and research visits to Brussels, Berlin and other EU capitals, as well as to China. Previously, she was the spokesperson for Austria's non-permanent membership in the United Nations Security Council. From 2001 to 2006, she was Foreign Affairs Spokesperson for the Austrian Chancellor Wolwgang Schussel and from 1996 to 1998, she was Spokesperson for the Austrian Federal Minister for Economic Affairs.

#### Dr. David SCOTT

Dr. David SCOTT holds a PhD from the University of Lancaster. He joined the Brunel University in 1992. As a Lecturer at Brunel University, Dr. Scott has worked on Asian religions and inter-faith issues, on Asian history and East-West encounters and on international relations. Dr. Scott's research covers three main topics: the rise of China in the international system, the rise of India in the international system, and East-West encounters (esp. Orientalism). Three books have been written by him on China's role in the international system. Alongside various articles on China's



public diplomacy and soft power drive, he has also published on the EU-China strategic partnership, environmental cooperation, and dialogue processes.

She is, as well, Senior Researcher of the European Integration Research Team and Director of the academic journal *Cuadernos Europeos de Deusto*. Prof. Perez de las Heras has taught courses on European legal issues at the Universities of Amsterdam, Oslo, Helsinki, Amiens, Nancy, Pau and the Iberoamerican University in México.

Prof. Jing MEN has been the InBev-Baillet Latour Chair of European Union-China Relations since 2008 in the Department of EU International Relations and Diplomacy Studies, College of Europe,. She obtained a PhD in Political Science (2004) at the Vrije Universiteit Brussel. Her research and teaching have been focusing on Chinese foreign policy and EU-China relations for more than ten years. She is the founder of the electronic journal *EU-China* Observer, launched at the beginning of 2009, where she edits and publishes articles on EU-China relations. Prof. Men has organised four large-scale international conferences on EU-China relations. The fifth conference, which is on "EU-China Soft Diplomacy", is scheduled on 18-19 April 2013.

## Prof. Stephan KEUKELEIRE

Prof. Stephan KEUKELEIRE has been Chairholder of the TOTAL Chair of EU Foreign Policy since 2011 in the Department of EU International Relations and Diplomacy Studies, College of Europe, and is also Jean Monnet Professor of European Foreign Policy at the University of Leuven. He is a graduate of the Universities of Leuven, Hull and Strasbourg and holds a PhD in Political Science of the Catholic University of Leuven. Prof. Keukeleire's research and publications mainly focus on the CFSP, EU diplomacy, structural foreign policy, the role of 'learning' in diplomacy, and the impact of the (re)emerging powers. He is co-author of the widely used textbook *The Foreign Policy of the European Union* (Palgrave Macmillan).

## Prof. PANG Chinglin

Prof. PANG Chinglin holds an MA in Oriental Philology from Catholic University of Leuven, and an MA in Asian Studies from UC Berkeley, an MA and PhD in Social and Cultural Anthropology from the Catholic University of Leuven. Currently, Prof. Pang teaches courses related to China, globalisation, migration and identity in the Faculty of Social Sciences at the Catholic University of Leuven and in the Business Department at HEC-ULg. Her research focuses on migration policies, mobility and intercultural flows between and in China and Belgium/EU. Prof. Pang is member of European and Asian networks in the area of anthropology, ethnicity, urban studies and development. Furthermore, she has done consultancy work for the International Organisation for Migration, the Belgian Foreign Affairs Department, and the Flemish administration of culture.

#### Ms. Floor KEULEERS
