**Mr Olivier COSTA** is the Director of the Department of European Political and Governance Studies at the College of Europe (Bruges, Belgium). He is also Research Professor at the CNRS (*Centre national de la recherche scientifique*), Sciences Po Bordeaux (Bordeaux, France). He is co-director of the Jean Monnet European Centre of Excellence of Aquitaine.

He is Associate Editor of the *Journal of European Integration* and member of the editorial board of the *Journal of Legislative Studies* and the *RISP: Italian Political Science Review*. His research and teaching deal with the European Parliament and the EU policy making, as well as with legislative studies.



**Mr Stephan LAUPER** is the Second Deputy Head of the Mission of Switzerland to the EU. He holds a Master's in International Relations from the Graduate Institute of International and Development Studies, Geneva. and until 2018 Mr Lauper joined the Swiss Directorate for European Affairs, as Head of Politics and Institutions, Switzerland. Since September 2018, Mr Lauper works for the Mission of Switzerland to the European Union, as Minister (Political coordination, Justice and Home Affairs).

**Mr Boris ZÜRCHER**, Dr. rer. pol., has been the Head of the Swiss Labour Directorate since 1 August 2013. Previously he was Chief Economist and Director of BAK Basel Economics AG, Basel. From 2007 to 2012 he was Chief Economist and Deputy Director at Avenir Suisse, a Think Tank for Economic and Social Issues, Zurich. From 2002 to 2007, Mr ZÜRCHER was economic policy consultant to Federal Councillors Pascal Couchepin, Joseph Deiss and Doris Leuthard in the Federal Department of Economic Affairs. From 1999 to 2002 he was the Head of the Labour Market Policy Division in the SECO. After completing an apprenticeship as a technical draughtsman, he studied for a university entrance

examination through evening classes in parallel with work. He then took economics and sociology at the University of Berne, where he has been lecturer since 2003.



**Mr Jesús BALLESTEROS** is the Director of the College of Europe Development Office. He joined the College in 2004 and has more than ten years of professional experience in business development, project design and management of applied research and service contracts. Mr BALLESTEROS is currently responsible for the coordination and the implementation of tailor-made training programmes for foreign, national and regional government officials and diplomats, as well as service contracts for the EU institutions, in particular for providing research and technical assistance in different EU policies. He has also extensive experience in event management, training and adult education in the field of

EU affairs, in particular in Training of Trainers (ToT), EU negotiations and the EU decision making processes.
