Professor Jörg MONAR is the Rector of the College of Europe (Bruges/Natolin, Warsaw) since 1 September 2013.

His previous positions include Director of the Department of Political and Administrative Studies of the College of Europe (2008-2013), Professor of Contemporary European Studies and Co-Director of the Sussex European Institute, University of Sussex (Brighton, UK), Director of the SECURINT Research project on EU internal security governance and Professor at the Robert-Schuman-University (Strasbourg, France) and Professor of Politics and Director of the Centre for European Politics and Institutions Professor of Politics (Leicester, UK).

In addition to his research and teaching functions Professor Monar has done advisory/consultancy work for the European Parliament, the European Commission, the Planning Staff of the German Ministry of Foreign Affairs, the Dutch Scientific Council for Government Policy (WRR, The Hague), the German Bundestag, the *French Commissariat Général au Plan* (Paris) and the British House of Lords and House of Commons (London). He is also a member of several academic advisory boards such as that of Access Europe of the University of Amsterdam and the Research Council of the European University Institute in Florence.

Professor Monar holds a Doctorate in Modern History from the University of Munich and a Doctorate in Political and Social Sciences from the European University Institute, Florence. He is the author of over 200 publications related mainly to European Union justice and home affairs and external relations as well as the institutional development of the Union. He is also a founding editor of the *European Foreign Affairs Review*.

He also managed Telecom Italia's relations with the OECD, the International Telecommunication Union (ITU) and other international associations and organizations. Previously, Dr. Pupillo held a variety of senior positions in the Strategy, Business Development and Learning Services divisions of Telecom Italia. He is an economist by training and has worked in many areas of telecommunications demand and regulatory

analysis, publishing four books on Internet Policy and many papers in applied econometrics and industrial organization. He has served as an advisor to the Global Information and Communication Technologies Department of the World Bank. Before joining Telecom Italia, he was member of the technical staff at AT&T Bell Laboratories in Murray Hill –New Jersey– and he worked as senior economist for governmental institutions. Dr. Pupillo is also an affiliated researcher at Columbia Institute for Tele Information at Columbia Business School and serves on numerous scientific and advisory boards around the globe. He obtained a PhD and an MA from University of Pennsylvania, an MBA from Istituto Adriano Olivetti in Ancona Italy and an MS in Mathematics from University of Rome.

Dr Robert DEWAR is the Head of Cyber Security at the Geneva Centre for Security Policy (GCSP). Robert holds an MA (Hons.) in Modern History from the University of St Andrews, an MSc in Global Security (Politics, Information and Security) and a PhD in Politics, both from the University of Glasgow. His PhD thesis was an examination of institutional dynamics in EU cybersecurity policy-making.

At the GCSP Robert provides executive education courses on cybersecurity and defence, the European Union and international relations as well as developing innovative pedagogical approaches to the teaching of cybersecurity. He also initiates and engages in international dialogue activities on cybersecurity and defence and conducts research into cybersecurity and defence policy, security studies, active and blended learning, the European Union and historical institutionalism.

Prior to joining the GCSP Robert was a Senior Researcher in the Cyber Defence Team of the Centre for Security Studies at *Eidgenössische Technische Hochschule Zürich* (ETH Zurich). He published papers on EU cybersecurity development, cyber defence policy and strategy, cyber weapons development and the use of exercises and simulations as teaching tools in cyber defence.

Before moving to Switzerland Robert was a lecturer and tutor at the University of Glasgow and the University of Stirling. He taught courses on international relations, cybersecurity and the European Union promoting the use of active learning in the classroom.

Robert is a dual German and British citizen and speaks German and English.
