

Prof. Dr Tobias Schumacher is the holder of the Chair in European Neighbourhood Policy at the College of Europe (Natolin Campus) in Warsaw, Poland, and an Associate Senior Research Fellow at the Centre for International Studies (CEI-IUL) at the University Institute of Lisbon.

He previously held positions at the University Institute of Lisbon, the Euro-Mediterranean Study Commission (EuroMeSCo), the Robert Schuman Centre for Advanced Studies (RSCAS) at the European University Institute (EUI) in Florence, the German Council on Foreign Relations (DGAP) in Berlin, and the University of Mainz.

He is the author of 70 books, book chapters, articles and policy papers on the European Neighbourhood Policy, Euro-Mediterranean relations, Middle East and North Africa politics, and Foreign Policy Analysis. He is the profiles editor of *Mediterranean Politics*, a member of the editorial board of *Insight Turkey*, a member of the international advisory board of the Lexington book series „Europe and the world“, and a regular contributor to the international media.

Dr Dimitris Bouris is Research Fellow at the European Neighbourhood Policy Chair, College of Europe (Natolin campus). Prior to joining the College of Europe, he was a visiting lecturer in Middle East Politics at Kingston University. Dr Bouris' research focuses on the Arab Spring, the European Union's role in the Israeli-Palestinian conflict as well as on the broader domains of state-building, security sector reform, and conflict resolution.

Dr Bouris holds a BA (Hons) in Political Science from the University of Crete, a MA in International Politics from the University of Manchester, and a PhD in Politics and International Studies from the University of Warwick. He is the author of "The European Union and Occupied Palestinian Territories: state-building without a state" (Routledge, 2014) for which he was nominated as Routledge Politics and International Relations author of the month for February 2014. Dr Bouris has published a number of scholarly articles in peer-reviewed academic journals such as *European Security*, *The Hague Journal on the Rule of Law*, *the Journal of Contemporary European Research* and *Political Perspectives*, as well as short articles and op-eds for *EU Observer*, *EurActiv*, *European Voice*, *Gulf News*, *New Europe*, *Revolve Magazine* and *Open Democracy*.

Ms Lily Habash-Hilal is currently working as a senior Institutional Development Expert at UNDP-Libya after having served as UNDP's Senior Governance Advisor during 2012-2013. She was the first Palestinian attending the "Institut International administration Publique (IIAP)" / "Ecole Nationale

Publique (ENA)". She holds a MA in International Relations from Birzeit University, an Executive MBA from Kellogg – Northwestern in Chicago and a Public Policy Diploma from the JF Kennedy School of Government, Harvard University. Currently, she is preparing a PhD at the University of Exeter, focusing on testing the viability of statehood under occupation in the case of Palestine.

Ms Lily Habash has been a pioneering civil servant and policy advisor (1994-2009) and devoted her career to the institutionalization of the various executive bodies of the Palestinian National Authority. She has initiated and established key Palestinian institutions, including the Technical Support Unit for the Palestinian economic negotiating team, the Negotiations Support Unit in the Negotiations Affairs Department of the PLO, and the Prime Minister's Office in 2003. She has also served different Palestinian ministers and Prime Ministers as an advisor and she has led the coordination for the government reform program during the period 2003-2009.

Ms Lily Habash is also a regional and global activist. She is an active member of the WANA Forum; she has been twice recognized for her leadership and vision for development by the World Economic Forum, Davos (1999 and 2003). She was selected as a Global Leader for Tomorrow in 1999, as a Young Global Leader in 2003, as well as a Young Arab Leader in 2003. Ms Habash was also recognized by the Women for World Peace Circle for her efforts in peace building.

Dr Anis Nacrou is a French diplomat and currently Acting Head of Delegation of the EU to Syria. He holds a PhD in political science from the Université de Paris I (Panthéon-Sorbonne) and has held senior diplomatic posts in Algeria, Bahrain, the United Kingdom, Israel, Qatar, the US and Yemen. He has been seconded by the French Ministry of Foreign Affairs and European Affairs and worked as political and security adviser to Mr Tony Blair on the Middle East Peace Process (2007-10) as well as in the British Foreign and Commonwealth Service (1996-97).

Prof. Dr Sharon Pardo (Ph.D., Ghent University, Faculty of Political and Social Studies) is a Jean Monnet Chair *ad personam* in European Studies and a senior lecturer in the Department of Politics and Government at Ben-Gurion University of the Negev (BGU), as well as the Chair of the National Jean Monnet Centre of Excellence – the Centre for the Study of European Politics and Society (CSEPS) and the Bologna Training Centre at BGU. He is the co-editor of the *Europe and the World* book series by Lexington Books. Dr Pardo is an Adjunct Senior Fellow at the National Centre for Research on Europe (NCRE), University of Canterbury, New Zealand, and a member of the National Executive of the Israeli Association of International Studies (IAIS). His research interests focus on the legal/political dimension of the EU Common Foreign and Security Policy.

Dr. Pardo also has significant interest in the development of the Euro-Mediterranean region and in European-Israeli relationship. He has published widely on these issues and he is the author of *Normative Power Europe Meets Israel: Fundamentals on Israeli-European Union Relations* (Lexington Books, forthcoming, 2014), and the co-author of the books *Uneasy Neighbors: Israel and the European Union* (Lexington Books, 2010) and *Israel and the European Union: A Documentary History*

(Lexington Books, 2012). Prof. Dr Pardo teaches courses on the European integration process and public international law.
