Building a European Energy Union is one of the main priorities of the Juncker Commission for the years ahead. This project aims at ensuring secure, affordable and low-carbon energy for citizens and businesses all across Europe in a spirit of solidarity.

A large part of the strategy proposed by the Commission on 25 February 2015 is devoted to the diversification of Europe's energy sources, through contact with countries in Europe's neighborhood. At the same time, the European Neighborhood Policy is being put to the test by geopolitics, both in the Southern and in the Eastern regions. The crisis in Ukraine along with the conflicts in the Middle East and Africa pose formidable challenges.

To meet the objectives of producing and acquiring secure, affordable and climate-friendly energy, the EU needs to renew its global energy diplomacy, embedded in a broader dimension of energy security. The review of the European Neighborhood Policy, set for November 2015, will be an excellent opportunity to bring in elements of energy security to the EU's primary tool for cooperating with its neighbors.

The Energy Union can also become a key driver for economic development in the EU by acting as a unique opportunity to trigger higher economic turnout while creating and securing employment in the energy sector. Deepened bilateral and multilateral cooperation with the European Neighborhood partner countries can significantly increase the EU's competitiveness on the international scene and support its economic recovery.
