

NATOLIN CLIMATE AND ENERGY NEST CONFERENCE CALL FOR PAPERS

"Revisiting the European Green Deal"

DESCRIPTION OF THE CONFERENCE

The Natolin Energy and Climate Nest is pleased to announce a call for papers for the student-led conference on the "Revisiting the European Green Deal". The conference will take place at the College of Europe in Natolin (Warsaw, Poland) on 20 June 2024.

The Natolin Energy and Climate Nest is a unique platform that combines both academic teaching and research, characterized by professional, and student-driven input. This year's topic deals with the inevitable link between climate and energy, thus highlighting the need for an effective and environmentally conscious perspective when tackling energy issues.

MAIN OBJECTIVES OF THE CONFERENCE

More than four years after the deployment of the European Green Deal (EGD), this conference aims to critically evaluate its practical consequences in a variety of areas. There are two main objectives that drive this goal.

First, the conference aims to facilitate an evaluation of EGD's accomplishments regarding climate and energy goals. This objective has at its core the purpose of evaluating past climate preservation-oriented actions.

Second, this conference hopes to facilitate discussions on the external effects of the EGD. This includes its impact on global markets and on power balance and how has the diffusion of EGD's objectives been received abroad.

The congress is driven by the increasing importance of climate issues in European policy and policies. As the European parliamentary elections approach, this topic is expected to have an impact on the new political cycle.

SCOPE

We are seeking papers relating to a wide range of topics of relevance to the area of the European Green Deal, including, but not limited to:

- I. PROGRESS OF THE EUROPEAN GREEN DEAL
- Technological innovations and drivers for the energy transition.
- Biodiversity and restoration improvements for climate neutrality.



- Economic competitiveness and resilience under the EGD.
- Public acceptance and social perception of the European Green Deal.
- II. EXTERNAL CONTEXT AND IMPACT OF THE EUROPEAN GREEN DEAL
- Green values diplomacy of the European Union.
- Spillover geopolitical effects of the European Green Deal.
- The European Green Deal and EU's neighbors.
- International supply chains for renewable energy sources and critical raw materials.

WHO CAN PARTICIPATE?

The application is open to practitioners and academics alike, including policymakers, representatives of NGOs, think tanks, and others. We hope to facilitate an interdisciplinary and critical discussion about the European Green Deal and its initiatives, thus contributing to ongoing research and offering information from different fields of study.

SUBMISSIONS

We are inviting 250-to-300-word abstract submissions and CVs of potential participants at the Conference before 18 February 2024 to <u>energyconference.natolin@coleurope.eu.</u> Contributions may be submitted in English in the form of an abstract. Each abstract will be reviewed by a selection committee comprising academics and practitioners. The successful applicants will need to submit a 7000-9000-word paper by the end of April 2024.

The successful authors may be invited to re-submit a version for further publication in a post-conference journal considering recommended modifications. The copyright remains with the authors.
