COURSE OBJECTIVE

To gain an understanding of the complex systems of governance that govern the internet particularly the platforms on which most online speech occurs today—as well as the anticipated and unanticipated consequences of new technologies on politics.

COURSE LEARNING OUTCOMES

Knowledge: A broadened understanding of complex systems of governance; a broadened working understanding of the influence of technology and the internet on global and EU politics; a basic understanding of how human rights and other legal frameworks interplay with internet governance; an awareness of the varying actors that guide and influence internet policy in the EU.

Skills: A broadened ability to analyse policies and laws both verbally and in writing; a basic ability to craft policy based on analysis of competing interests.

RECOMMENDED PREPARATION

Students would benefit from familiarizing themselves with topics of internet governance and politics, such as the current debates, for instance, over the EU Copyright Directive, the Digital Services Act, or the EU Terrorism Directive. Recommended websites to read include:

TEACHING METHOD(S)

The course will largely be taught live, but course material may include pre-recorded videos; readings (of articles, book chapters, and/or policy papers) and participation in a class forum.

Students will be expected to submit no fewer than two written assignments (essays, analysis, and creative assignments) during the duration of the course.

ASSESSMENT METHOD AND CRITERIA

Students will be assessed first and foremost on the basis of a 3-hour written, open-book, digital, in-class examination, based on a topic selected from several options provided to them (50%).

In addition, students will be assessed on a short 5 minutes in-class presentation (20%), and a written assignment of 2000-2500 words on a topic to be agreed with the professor (30%).

The College of Europe reserves the right to change the delivery and assessment of the course in case of circumstances beyond the reasonable control of the College (force majeure). Any communication from the campus administration in this regard takes precedence over the information provided in this ECTS card.

Retake examinations, i.e. exams passed in the second examination session, will have the same format as those taken during the first exam session. The only exception concerns oral exams, which are replaced in the second exam session by written exams. When a student takes an examination during the second session, the final mark for the course is based solely on the result of the retake examination. No other element of evaluation which would have been taken into consideration in the calculation of the final mark during the first examination session will be considered in the second session. COURSE MATERIALS (readings and other learning resources/tools)

Students will be presented live lectures and will be expected to read both assigned readings and articles that they locate and identify on their own, based on criteria given in the class. Students will also participate through submissions to a class forum. Finally, students will be provided with videos (such as TED talks) and podcasts to watch or listen to during the course period.
