COURSE OBJECTIVE

This course is designed to provide students with knowledge of China's foreign and security policies today. Being a socialist country and now a great power with a strong nationalistic posture, how China situates herself in the world arena, and shifts her foreign and security policies under president Xi Jinping will be thoroughly examined. China's main bilateral relationships will also be analysed.

COURSE LEARNING OUTCOMES

By the end of the course, students should be able to:

- Describe the foreign and security policies of China today in relation to the changes in international order and domestic politics.
- Summarize the process dynamics of political change of China's foreign policies from opening to the West to today'.
- State the main issues influencing Chinese diplomacy and its future changes.
- Identify how China sees the world and the changes in world equilibrium.
- Understand China's main external bilateral relationships.

RECOMMENDED PREPARATION

Required readings have been provided. Students can already use the recommended textbook and the bibliography to get prepared to each session.

TEACHING METHOD(S)

Lectures.

ASSESSMENT METHOD AND CRITERIA

The course assessment will be based on two elements:

- paper on a topic provided by the Professor, 2000 2500 words, including footnotes, excluding bibliography) (40%)
- final 2-hour closed-book digital in-class written exam, two questions to be answered from a choice of four questions (60%)

Retake examinations, i.e., exams passed in the second examination session, will have the same format as those taken during the first exam session. When a student takes an examination during the second session, the final mark for the course is based solely on the result of the retake examination. No other element of evaluation which would have been taken into consideration in the calculation of the final mark during the first examination session will be considered in the second session.
