COURSE OBJECTIVE

The course will provide insights from an active participant in the development and implementation of the Paris Agreement to enable students to get a good understanding of the multilateral climate change regime, the challenges faced in the negotiation process, and some of the key issues to be addressed in the coming years to strengthen climate action.

COURSE LEARNING OUTCOMES

- Students will be familiar with the basic political and institutional context of the Paris Agreement, how it was developed, and the current state-of-play surrounding its implementation.
- Students will be able to understand the climate negotiation mechanisms, name main stakeholders and explain some of the differences in their positions.
- Students will be familiar with key differences among national governments and international organizations in the context of climate negotiations and implementation of the Paris Agreement.
- Students will be able to discuss and debate issues related to strengthening climate action including challenges for 2022 and 2023.

RECOMMENDED PREPARATION

None, preparatory readings recommended in the course materials.

TEACHING METHOD(S)

Presentations and interactive discussion.

ASSESSMENT METHOD AND CRITERIA

The compact seminar will be assessed on a 'pass/fail' basis through:

- an online multiple-choice test (80% of the mark) at the end of the final course session - 15 minutes to answer 7 questions, and
- overall attendance (20% of the mark).

The weighted average of both assessment elements needs to be equal or greater than 50% for a student to pass the compact seminar.

Each student is entitled to re-taking the test once. The re-take test would account for 80% of the mark whilst overall attendance would account for the remaining 20%.

Since compact seminars carry no ECTS credits, the final result will be present on the transcript, but will have no impact on the student's final average, nor on the overall grade, nor on attaining the diploma.

COURSE CONTENTS

- The nature of the climate challenge and the role of the multilateral climate regime – some context and background on the history of the process, how it works, the interests and concerns of different countries, groups, and other participants including non-party stakeholders.
- Getting to an agreement in Paris – the framing of multilateral negotiations leading to COP21, the preparation of the French COP21 presidency and organization of the conference, key issues that divided parties, the use of informal and other tracks, facilitating agreement, and getting to a deal.
- How the Paris Agreement is intended to work – a shared set of objectives, bottom-up targets, top-down rules and processes, collaboration and cooperation.
- Ongoing challenges for implementation – building ambition, ensuring action and delivery, deepening the involvement of non-party stakeholders, preparing and making full use of the 2023 global stocktake.
- Some of the limits of the Paris Agreement and linkages to wider processes and challenges.
