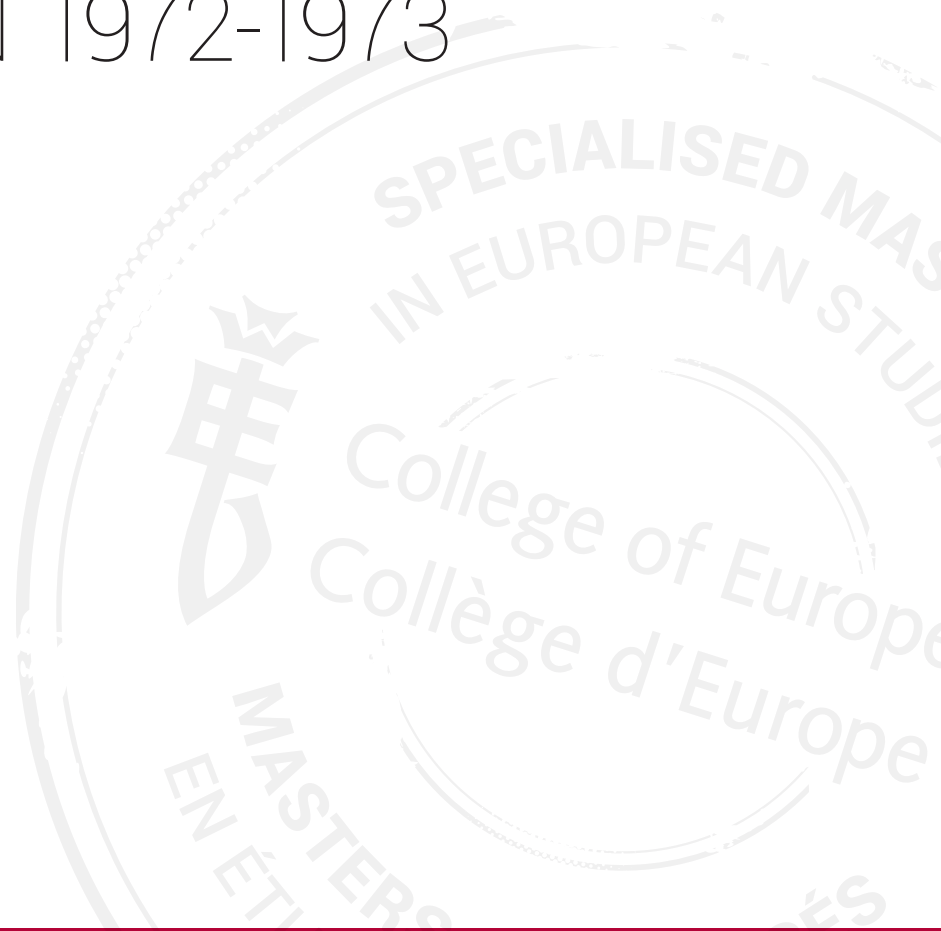


# RICHARD N. COUDENHOVE- KALERGI PROMOTION SCHOLARSHIP FUND PROMOTION 1972-1973

Funding your studies can be challenging, however approximately 70% of College of Europe students are granted scholarships by their government or by public or private institutions.

It is thanks to the numerous scholarships, subsidies and donations received, that the College of Europe has been able to train and educate such a large number and variety of successful graduates.

**Help us to continue to pursue our mission of training cross border leaders for both the public and private sectors, by financially supporting the best students in their field to come to the College of Europe and help us to welcome them in the best conditions possible.**



## A SCHOLARSHIP

### The cost of a scholarship a year...

A full scholarship for the College of Europe including tuition, accommodation and meals is currently € 25,000. This may appear rather high, but actually falls short of the full cost of a student to the College which currently amounts to € 42,000. To be able to support an annual scholarship, therefore, we must be ambitious in our fundraising goal.

### Assuring continuity...

The Richard N. Coudenhove-Kalergi Promotion Scholarship Fund should not be ephemeral—we should aim for continuity. Our thinking is that we should commit to providing a full scholarship for at least 5 years in a row, if possible for 10 years.

Should we collect less funds than we initially envisage, then we think it would be better to provide a partial scholarship (e.g. tuition only, or 50% of the full amount) but nevertheless to ensure that the Richard N. Coudenhove-Kalergi Promotion Scholarship Fund pays out over a number of years rather than start with a bang and then fizzle out as fast as the project was ignited.

### Ensuring best value for donors...

Such a project cannot be envisaged without considering the administrative aspects in some detail. So, naturally, we have done that. Of course, an important consideration in this context is the possibility of **a tax reduction for donors for the donations they make**. We have paid particular attention to this.

### The King Baudouin Foundation

To tackle these aspects in a fully professional manner, we propose the creation of a Fund under the auspices of the King Baudouin Foundation (KBF) in Belgium.

The KBF is an independent, pluralistic foundation working in Belgium and at the European and international levels. It was set up in the late 1970s to mark the 25th anniversary of Baudouin's accession as King of the Belgians. In Belgium, the Fondation Roi Baudouin or Koning Boudewijnstichting has instant name recognition as the country's leading centre for philanthropy. In its own right, the KBF seeks to change society for the better and invests in inspiring projects and individuals. You can find out more at [www.kbs-frb.be](http://www.kbs-frb.be).

Significantly, from our perspective, the KBF also manages philanthropic funds set up by (groups of) individuals. Indeed, it has vast experience in this regard. This, of course, is where the Richard N. Coudenhove-Kalergi Promotion alumni can link in.

A major advantage—apart from partnering with an organisation used to managing such funds—is that donations through the KBF benefit from significant **tax advantages** in Belgium. The government returns 45% of donations made in Belgium in the form of a tax rebate.

Better still, the KBF works with the **Trans-national Giving Europe network**, which means that if you donate money from other European countries or the US for a project in Belgium you may **receive tax advantages in the country where you live** (see annex 3).



# DONATING

## Who can donate...

Donations to the sort of fund that is envisaged for the Richard N. Coudenhove-Kalergi Promotion Scholarship Fund can be made by individuals and also by companies. It goes without saying that anyone who wishes to donate to the Scholarship Fund may do so and not only members of the Richard N. Coudenhove-Kalergi Promotion.

This is important as it also opens up the possibility that, if desired, we can in due course seek financial contributions from others (perhaps corporate benefactors) who may wish to support the initiative. Alumni who are not a resident of a country associated to Transnational Giving Europe, can pay directly to the College of Europe.

The KBF will not disclose the names and contributions of individual donors. Should any donor wish to be acknowledged as such, we think it will be possible for us, as the sponsors of the initiative, to make appropriate disclosure to the proper audiences (the College, the alumni, the students of the current year, etc.) at the right time.

We suggest that we publish the names of the individuals who wish to be identified, but not the amounts donated by each of them.

## Selecting scholars...

Scholarships are only attributed to students who need it.

The College of Europe proposes at least three candidates to the godparent(s) of the Promotion Scholarship Fund. The godparent(s) of the promotion make(s) a selection among the proposed candidates within a fortnight.

## So, what next?...

In order to put this initiative on a sound financial footing, it would be preferable by far to gather a large sum at the start rather than launching a fresh call for contributions each year. Despite our dedication to the cause an extensive annual canvassing for contributions is simply not sustainable.

We recognise, however, that some individuals will prefer to commit to making a certain financial contribution annually over x number of years, rather than paying out "up front" the full amount of what they are ready to donate. We do aim to facilitate that approach too. Yet, the ensuring that the Fund can be sustained for an extended number of years and—why not!—grown, by seeking additional benefactors.

## RICHARD N. COUDENHOVE-KALERGI PROMOTION SCHOLARSHIP FUND - PRACTICALITIES

The King Baudouin Foundation collects the funds in Belgium and delivers a tax certificate for fiscal residents in Belgium.

Residents of countries covered by the "Transnational Giving Europe" network (please see the list in annex 3) should pay to the institution affiliated to the network in their country. That institution will deliver an appropriate tax certificate according to national rules.

Details such as precise bank account numbers can be found in annex 3.

Residents of countries other than those below who wish to donate can contact Prof. Dr. Norbert Vanhove, Treasurer of the College of Europe, to discuss the best way forward and

possible adapted solutions for you.

Please note that the minimum donation in order to benefit from tax relief in Belgium is €40 per year; the maximum amount that is considered for a tax credit is €366,000, whether paid by individuals or by corporations. Different minima/maxima will apply in other countries. You should kindly check the local situation yourself if this is of concern to you (and perhaps share this information with other alumni of your promotion based in your country).

Should you wish to pay annually, we strongly encourage you to set up a standing order.

The concept of a 'donation' is different from 'sponsoring'. In order to be considered a donation, not least for fiscal purposes, donors

(be they private individuals or companies) cannot claim anything in return, receive favourite treatment or obtain free publicity.

The KBF has a direct subsidiary in the USA. Donations made from the USA should therefore qualify for tax relief in the USA.



## SOME USEFUL SIMULATIONS

Below you will find two hypothetical examples of how many people and what amounts it would take to fund a scholarship taking into account the operating fees charged by the King Baudouin Foundation for the administrative and management services it provides.

**Example A** is for a partial scholarship of € 16,000 over a 10-year period.

**Example B** is for a full scholarship of € 24,000 over a 10-year period.

As regards the tax advantage, this is based on the Belgian situation, but the position might be similar in other countries. However, please make sure to obtain your own tax advice taking into account local tax laws as well as your own personal situation.

The table is based on one-time donations. If you prefer to pay a smaller amount but do so annually, divide the figure you had in mind by the number of years. A one-off donation of, say € 5000, is equivalent to 10 yearly donations of € 500 each, and so on. The choice is yours!

We do, however, appeal to those able to do so to pay up front, or perhaps over the first 3 years: collecting funds each year is burdensome and carries the risk that the amount available for the scholarship varies from year to year.
