

# Master of Arts in Transatlantic Affairs

Challenges such as the complex negotiations on the Transatlantic Trade and Investment Partnership, or the revival of the North Atlantic Treaty Organization, or the fight against extremism, must be tackled by a new generation of experts who can assume influential roles in transatlantic affairs. To prepare graduates for such positions of leadership, The Fletcher School of Law and Diplomacy and the College of Europe -- the world's first institution of postgraduate studies and training in European affairs -- offer a unique joint degree: the Master of Arts in Transatlantic Affairs (MATA).

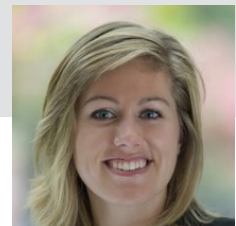
Students in the MATA program spend one year on each side of the Atlantic. Both institutions create a community setting, integrating students into a close-knit, multinational, and intercultural learning environment. The first year is dedicated to coursework, including a joint, year-long and project-oriented course on transatlantic affairs. The second year incorporates a high-level internship with a transatlantic focus.

## Start at The College of Europe

### Semesters 1 & 2

- Spend two semesters completing coursework at the College of Europe
- Complete a subset of courses from one of the following study tracks:

*Economic Studies*

*Interdisciplinary Studies (Natonin)*

*International Relations & Diplomacy*

*Legal Studies*

*Political & Governance Studies*

- Participate via video conference in a joint Fletcher/College of Europe course

### Semesters 3 & 4

- Spend one semester enrolled in four courses at The Fletcher School
- Spend the other semester (3-4 months) in the U.S. completing an internship with a transatlantic focus (Fall or Spring)
- Complete a research thesis on a transatlantic affairs topic

## Start at The Fletcher School

### Semesters 1 & 2

- Spend two semesters completing eight courses at The Fletcher School
- Meet the Breadth Requirement by taking one course from each division:

*International Law and Organizations*

*Economics and International Business*

*Diplomacy, History and Politics*

- Participate via video conference in a joint Fletcher/College of Europe course

### Semester 3

- Spend the semester (3-4 months) in Europe completing an internship with a transatlantic focus

### Semester 4

- Spend the semester at the College of Europe enrolled in a subset of courses from one of the College's study tracks
- Complete a research thesis on a transatlantic affairs topic
